September 30	NNP-TELFAIR, LP conveys to FBISD 65.052 acres of land, being a portion of the 1651 acre tract conveyed to NNP- Keepsake, LP by the General Land Office of the State of Texas (the Property).

March 28	FBISD Board authorizes Superintendent to engage Stantec to provide professional design services for career and technical center.
November 14	FBISD names site as the James Reese Career and Technical Education Center (CTEC).

August 30	FBISD Board authorizes Superintendent to engage Bartlett-Cocke (Bartlett) as General Contractor of the CTEC.
August 31	FBISD issues Bartlett a Notice to Proceed.
October 02	Bartlett performs preliminary activities on the Property.
October 03	Kevin Hitchcock (Hitchcock), Jacobs' construction manager, receives a call from Texas Historical Commission (THC) regarding the start of construction on the Property.
October 03	Reginald Moore (Moore) visits with Bartlett personnel on the Property.
October 04	FBISD contacts Bill Martin (Martin) with THC requesting guidance.
October 04	Hitchcock sends THC a copy of the QC Laboratories Cultural Resources Report. TMC/Martin provides direction to FBISD/Bartlett regarding the report, including proposal for archaeologist to observe activity.
October 05	Bartlett informs FBISD that Moore had come to the property on October 3, 2017, claiming that FBISD was attempting to build on a historical gravesite. Moore displayed a THC document, with a highlighted section regarding ground-disturbing activities, recommending an archeological survey be conducted.
October 05	Email from Oscar Perez (Perez) to Superintendent Charles Dupre (Dupre) informing him of Moore's visit to the Property.

October 06	THC letter to Carolina Fuzetti (Fuzetti) referencing SWCA Environmental Consultants and proposing an archeologist monitor the earthmoving on the Property.
October 09	Email from Perez to Dupre informing him that Fuzetti had spoken to Moore and that Stantec is requesting an archeologist's proposal for observation of earthmoving activity on the Property. FBISD requested Bartlett wait until an archeologist is ready to staff the project before

- October 10 FBISD contracted with Goshawk Environmental Consulting, Inc. (Goshawk) to provide archeological survey of the 15 acres designated as the CTEC site. The scope of work is to provide observation of land clearing, trenching and excavations on site.
- October 11 THC issues Antiquities Permit No. 8197 that governs the discovery of this abandoned cemetery to Goshawk.
- October 13 Bartlett official construction mobilization.

beginning any earthmoving.

November 7 Dupre meets with Moore.

<u>2018</u>

- January 12 Goshawk completes observation of construction activities, including land clearing, trenching and excavations for archeological survey, without any significant findings.
- February 12 Trustee Dave Rosenthal speaks with Moore during the Board Listening Tour at Hodges Bend MS.
- February 19 Bones discovered at the CTEC site during backfill of a drainage pipe trench. FBISD notifies Goshawk of the discovery.
- February 20 Goshawk representative observes the bones and recommends FBISD contact City of Sugar Land Police's Crime Scene Investigation Unit (CSI). CSI officer determined the bones were not part of a crime scene.
 FBISD police delivered the bones to the Galveston County Medical Examiner's Office, who consulted with Dr. Joan Bytheway, Forensic Anthropologist at Sam Houston State University. Based on a review of photographs, Bytheway opined that the bones were not human.
- February 22 FBISD requested written statement from Bytheway affirming that the bones were not human. Bytheway then requested to see the actual bones before putting anything in writing rather than rely on photographs.

February 26	FBISD police delivered the bones to Bytheway for examination, who made a final determination that the bones were human.
February 27	FBISD contacts Goshawk to develop next steps.
March 02	Goshawk emails proposals for next phase of exploration.
March 12	Goshawk mobilizes for exploratory survey of bones found on CTEC site.
March 21	Goshawk's Forensic Anthropologist, Dr. Catrina Whitley, visits CTEC site to observe single findings.
March 22	Fuzetti emails Micki Morris (MMorris), with Rogers, Morris & Grover (RMG), forwarding email from Clark that bones were confirmed as human and seeking counsel on legal implications. Discovery was believed to be a single interment (only one body).
March 23	Goshawk delivers email report of potential single findings.
March 27	Bartlett provides excavator equipment to Goshawk.
March 28	Telephone conference call with FBISD, Jacobs and RMG to discuss next steps. RMG prepares statutorily required Notice of Existence of Abandoned or Unknown Cemetery to file with County Clerk.
March 30	Notice of Existence of Abandoned or Unknown Cemetery filed with Fort Bend County Clerk with a copy to the THC, as required by law. (Official recording date of April 2, 2018).
March 30	Goshawk locates second interment on CTEC site.
April 3	Goshawk locates 20 additional interments on CTEC site.
April 3	FBISD issues stop work order to Bartlett for paving on northwest corner of CTEC site.
April 5	FBISD issues stop work order to Bartlett for area east of the main building.
April 6	Dupre calls Moore to inform him of the cemetery discovery prior to news release.

April 9	Meeting on CTEC site with Stantec, Bartlett, Goshawk, MMorris, and FBISD (Perez, Fuzetti and Rob Scamardo) to discuss investigation plan, construction impact and options. Advised Board of Trustees in closed session of the discovery. Board directs RMG to pursue legal authority to remove remains and coordinate with City for possible

	relocation to City-owned Imperial Prison Farm Cemetery (Imperial Cemetery).

June/July	CoSL engages Goshawk to verify that area of planned interment at Imperial Cemetery does not have abandoned, unmarked graves. MOU and Board Resolution drafted with input from CoSL, Scamardo, Sopher and Amanda Bubela.
June 1	Goshawk identifies the perimeter of the abandoned cemetery and discovered 95 interments.
June 4	434 th District Court grants FBISD's Petition to Exhume Human Remains.

June 6	Dupre receives voicemail from Moore asking for dirt from the CTEC site.
June 14	Perez meets with Moore, UH Professor Dr. Ken Brown and Richard Vogel at the CTEC site.

June 28	Sopher attends a CTE Planning Site Visit with Bryan Ray, Jacobs Property Manager.
July 11	Sopher speaks to Moore regarding the format for the media event scheduled for July 16.

August 14	Sopher attends a meeting at City Hall about the cemetery discovery.
August 16	Sopher gives presentation to the Fort Bend Museum Committee about the discovery at the CTEC site at (no handouts, presented slides of photos from the site).
August 16	THC/Mercado-Allinger's letter to Dupre responding to his request for invasive testing as stated in his letter of August 10; hand delivered.

- August 17 Dupre hosts joint meeting with representatives of THC and CoSL to discuss authorization for invasive analysis and need for community input. Attendees: Mercado-Allinger, Martin, Clark, Perez, Sopher, Scamardo, MMorris, CoSL City Manager Allen Bogard and Griffith.
- September 1 Goshawk completes exhumation of remains and over-dig of cemetery.
- September 3 Sopher attends the Convict Lease Labor Day Memorial & Symposium at the CTEC site.
- September 5 City Manager Scamardo and Sopher attend the first meeting of the City Manager's Task Force on Convict Lease Memorial meeting at City Hall. Moore attends. Out of county residents, Sam Collins with National Trust for Historic Preservation and Swatara Olushola with NBUF, introduced as members of the Task Force.
- September 19 Scamardo and Sopher attend the Task Force meeting at the T.E. Harman Senior Center. Moore's request to serve as "guardian" of the cemetery rejected by Bogard and deleted from agreement.
- September 25 CoSL Assistant City manager Douglas Brinkley to Dupre reporting on unanimous agreement of Task Force to proceed with DNA analysis.
- October 02 Scamardo writes THC/Mercado-Allinger reporting on unanimous agreement of Task Force on conducting invasive analysis.
- October 03 Scamardo and Sopher attend meeting at City Hall to finalize negotiates of an Interlocal Agreement.
- October 03 Sopher attends a Genetics Presentation at City Hall.
- October 03 Sopher and Scamardo attend the City Managers Task Force meeting at City Hall.
- October 04 Sopher gives presentation at the Fort Bend Heritage Committee meeting about the findings at the CTE site (no handouts, presented slides of pictures from the site).
- October 08 THC/Mark Wolfe letter to Scamardo stating that the THC "has no authority over the ultimate decision as to whether or not destructive analysis is performed and takes no position on destructive testing of these remains. NOTE: This is a reversal of the manner THC had historically responded to this issue and contrary to what Mercado-Allinger stated in August 17 meeting. The CoSL formed the Task Force for the primary purpose of demonstrating community support to the THC.
- October 10 Scamardo and Sopher join conference call with the Burial Location subcommittee of Task Force and explain the legal obstacles to reinternment. Subcommittee acknowledges Imperial Cemetery as most viable option.

October 15	FBISD Board unanimously approves the Interlocal Agreement with CoSL for reinternment in the Imperial Cemetery. Moore address Board during public comment and implies Newland Development and the CoSL knew of the abandoned cemetery and FBISD should hold them accountable for withholding that information from FBISD. FBISD delays filing Petition to reinter or setting hearing for 3 weeks until after bond election on November 6.
October 17	Sopher and Perez attend the Task Force meeting, which votes to reinter the human remains at the CTEC site.
October 18	Sopher has a conference call with Clark to debrief on the October 17 Task Force meeting.
October 18	Dupre meets with Moore.
October 18	2:30 pm – Jason Burdine, Dupre, Board Counsel Rick Morris, Dupre and Scamardo meet with Moore to learn what information Moore has to support his public comments at the October 15 Board Meeting.
October 23	CoSL unanimously approves the Interlocal Agreement with FBISD for reinternment in the Imperial Cemetery.
October 29	Scamardo letter to Moore confirming that Moore does not have any direct evidence of Newland's or the CoSL's knowledge of a cemetery on the Property before it was sold to FBISD.
November 2	News Release: Fort Bend ISO to continue discussions regarding future
	Interment of remains discovered at abandoned and historic cemetery
November 7	Petition to Removal of Remains from Abandoned Cemetery and For Removal of Dedication for Cemetery Purposes filed. Court scheduled hearing on Monday, November 19.
November 8	FBISD hires Anid Lee to facilitate FBISD's Advisory Committee on Sugar Land 95.
November 19	434 th District Court holds hearing on the District's Petition for Removal of Remains from Abandoned Cemetery and For Removal of Dedication for Cemetery Purposes from the CTE Center Site. Allows "member of the public" to address the Court.
November 21	Court appoints Michael Elliott (Elliott) as Master in Chancery with broad authority to "assist in the investigation, to assist in the legal discovery in the case and in the promulgation of options and potential resolutions for the Court to consider."
November 22	Thanksgiving Day
November 26	Meeting with Dupre, Sopher, Perez, Fuzetti, Scamardo and MMorris. Dupre advised that he had already directed Design & Construction to work with Stantec to redesign site to relocate E wing; Perez and Fuzetti

shared Stantec's preliminary concepts for relocation; Dupre advises Moore of new strategy, that FBISD will not build on site of discovery, and will leave cemetery designation in place. Dupre proposes to meet with community activists to obtain their agreement on his plan to relocate bodies to Imperial Cemetery in exchange for leaving designation of cemetery on CTEC site (the "win/win" proposal).

- December 05 First meeting of the FBISD Advisory Committee, Dupre and Sopher attend. Dupre addresses Advisory Committee and expresses openness to preservation of cemetery on CTEC site, solicits feedback for potential new options for solution.
- December 10 MMorris and Scamardo provide full update to Board in closed session. Directed by Board to proceed with aggressive legal strategy, mandamus of judge and continued pursuit of relocation of bodies.
- December 17 434th District Court conducts hearing on FBISD's Objection to Appointment of Master.
- December 18 Petition for Mandamus filed in the 14th Judicial District Court of Appeals, transferred by court to the 1st Judicial District Court of Appeals, seeing an Order for 434th District Court to vacate its order appointing Master.
- December 19 RMorris meets with County Attorney Roy Cordes to dissuade County from intervening in suit.
- December 20 Appellate Court Orders Stay of Order Appointing Elliott as Master.
