Hi Mr. Elliott –

Subject to and without waiving any objection pending with the Court as to your appointment, I believe there is a mistaken understanding underlying your request. FBISD does not have and is not aware of any information regarding the identity of any buried individuals or their descendants. While there are some names in historical records of individuals who may have been incarcerated at the prison camp at some point during the relevant time frame, FBISD has no information as to whether any such individuals died or were buried at this site. In other words, it is not possible to scientifically match lists of suspected prisoners to any of the discovered remains. Since none of the deceased individuals have been identified, there is no way to identify or notify respective descendants, as pointed out to the Court in FBISD's Petition seeking permission to reinter the remains. For this reason, FBISD is willing to and has sought permission from the THC to obtain and curate genetic material from the remains, in order to have such material available for possible future invasive testing against the DNA of persons who may come forward in the future to request permission to establish such descendant status.

If it would be more helpful to have a telephone conference to further discuss this issue, please let me know when you are available.
