SYNOPSIS:

I, Fort Bend ISD Police Officer R. Hilliard III #C117, am assigned to Christa McAuliffe Middle School, located at 16650 South Post Oak, Houston, TX 77053. On November 27, 2019, I was dispatched to the James Reese Building. I was made aware of a suspicious black male attempting to take photos of the Sugar Land 95 bodys gravesite. A criminal trespassing warning was issued. This case is closed with a citation issued.

#### SCENE SUMMARY:

James Reese Technical Building is a public school, located within the Fort Bend Independent School District, with a physical address of 12300 University Blvd., Sugar Land, Texas, 77479.

**DETAILS:** 

On Wednesday, November 27, 2019 Fort Bend ISD Sergeant Walton contacted I, Fort Bend ISD Officer Hilliard C#117 was summoned to the James Reese Technical Building in regards a suspicious black male attempting to take photos of the Sugar Land 95 bodys gravesite earlier that day.

Upon my arrival, I Officer R. Hilliard III met with Officer Camacho and FTO Torres-Rangel regarding the matter at hand. Officer Camacho staged on one side of the parking lot and I staged on the other side of the parking lot near the graveyard.

Officer Camacho advised early today a black in color, Nissan Truck bearing Texas License Plate was observed on the Reese Technical Center campus. That vehicle was occupied by a black male. That black male was observed walking toward the graveyard and trying to take photos. At that point, that black male was ran off promises by the site supervisors.

Fort Bend ISD Dispatch advised the vehicle retuned to Reginald Moore.

After staging in my designated area, Officer Camacho advised she observed that same black in color pickup truck again on campus. Officer Camacho pulled behind the vehicle and the vehicle keep moving. At that point, I went to my patrol vehicle and observed the vehicle leaving out the campus parking lot and making a U-turn on University Blvd. headed towards State Highway 6.

I, Officer R. Hilliard III pulled behind that vehicle and gave dispatch the Texas LP that was bearing on that vehicle. Dispatch confirmed that vehicle returned to Moore. I, Officer R. Hilliard III was summoned by Sergeant Walton to log information and not to stop that vehicle. Shortly later, I was contacted via telephone by Sergeant Bennett and was summoned to stop that vehicle and if indeed it was Moore driving that vehicle give him a Criminal Trespass Warning. I, Officer R. Hilliard III in my clearly marked patrol vehicle, activated my emergency lights on my patrol unit to effect a traffic stop.

Upon approaching the driver's side of the vehicle, I observed it was occupied solely by a male driver. I made contact with the driver and informed him the reason for the stop and requested his driver's license and proof of insurance. The

driver handed me his Texas Driver License that identified him as Reginald Moore and date of birth

While speaking to Moore, I asked him Why was he at Reese Technical Center. Moore stated, He was monitoring, hes the guardian of the Sugar Land 95.

Moore did confirm he was at the James Reese Technical Building earlier that day. Moore began to ask if we still had an Officer by the name of Paxton that still worked for FBISD Police Department. That Officer Paxton use to work with me at TDC. Moore then stated he knows Brian Middleton and we are real close (Fort Bend County District Attorney). Im on his transition team reform committee. He supports whats we are doing.

Moore began to state, I dont blame you, and youre just doing your job. They sent you brothers out here so they would not have to send a white officer; because they dont want the white officers to look like they racist. Ive been waiting for this ticket, please believe me.

I, Officer R. Hilliard III went back to my patrol vehicle and wrote Moore a Criminal Trespassing Warning (CTW).

I, Officer R. Hilliard gave Moore all pertinent information regarding the stipulations regarding a CTW. Mr. Moore was very calm while receiving notification of the CTW.

Moore was issued a CTW and was released without any further incident.
